Non US Resident Guide to Employer ID Num

Employer Identification Number (EIN) also known as Employer Federal Tax Identification Numbers (FEIN) is the federal tax ID issued by the United States Internal Revenue Service (US IRS) to identify your business. EIN is extremely important as every bank, vendor, customer, employee and other parties your business transact with, may ask you for that number to open an account, receive payment, process payroll and more.

Who must obtain an EIN?

The Internal Revenue Code (IRC) which governs the U.S. Federal tax law determines who must, by law, to apply and obtain an EIN for your business. If your business meets the following criteria you fall under that category: you have employees, your business is organized as a corporation, partnership or a Limited Liability Company, Your business offers a retirement plan benefits or if your business will have non-resident on income.

How to obtain an EIN?

The IRS is the U.S. Government agency responsible to process EIN applications, approve or reject them and issue these numbers to applicants.

Which information does the IRS require?

For a non American owned business, obtaining an employer ID number is not simple. One of the requirements of an EIN application (Form SS4) is to identify the company officer who will be responsible before the IRS of all tax matters. One of the items the IRS requires an applicant to fill out the Officer's U.S. Social Security Number. Obviously, a non-US-resident does not have such a number and this complicates the process.

Can a Non-US-Resident obtain EIN without having Social Security Number?

Yes, even though it is complex, there is a process that allows Non-Resident Owned Business to qualify for Employer ID Number without the officer having a U.S. Social Security Number.
